# **Technology Director Report**

April 13, 2011

#### **Online Testing**

We finalized preparation for online ISTEP+ testing for grades 5 and 8 over spring break. We are conducting practice tests this week and thus far results have been very good. I also updated the software and configuration for End of Course Assessment testing over spring break.

#### On-line Tech Plan

Indiana is moving to a system where each school's three-year tech plans will be submitted to an on-line version that is to be available to the public sometime over the summer. Our current tech plan for July 1, 2010 – June 30, 2013 had already been written and approved. However, we had to add some components and do some updating to the plan to meet the on-line criteria. I am happy to report that our updated tech plan has been submitted and approved by the DOE.

#### **E-rate Approval**

I have submitted and received our funding approval for e-rate discounts for telephone service and web hosting. We will be moving our digital phone circuit from AT&T to Education Networks of America (ENA). The e-rate discount will amount to a 50% savings on our monthly fees, which is similar to previous years. The decision to move from AT&T to ENA was made based on the following factors:

- Total monthly cost will be the same or less than AT&T
- There will be no long distance fees to anywhere in the continental United States which will eliminate a separate monthly bill and the accounting/time involved in retrieving personal long distance call payments.
- We have had considerable interruptions in our phone service from AT&T that is provided over traditional copper wire with various junction points between here and Russiaville. The ENA service will be over the fiber network that also provides our Internet Connectivity. Our ENA service has been up 99.7% of the time with only one minor outage affecting us during school hours which lasted about one hour.

We will also be moving our web pages to a hosted service over the summer as a result of receiving e-rate approval for web hosting services. This will allow individuals to update building and teacher web sites without having to know how to write html code. We will be using a product from One Technologies, Inc. call Mambo Schools, which is in use by over 250 schools in Indiana.

## **Other News**

- Our Skyward training for next year scheduling went very well and our high school and middle school are working on schedules for next year. Our next milestone will be on May 13, when we send our complete demographics and medical data for conversion.
- I am currently working with Karen Keisling to complete the April 1 Special Education report.

- 5. Superintendent: Dr. O'Rourke submitted the following report:

## **Superintendent's Report**

## April 19, 2011

1. Kokomo Area Special Education Cooperative (KASEC)

The seven remaining school corporations – Eastern, Maconaquah, Northwestern, Taylor, Tri Central, Tipton, and Western continue to meet and develop transition procedures in anticipation of Kokomo's withdrawal from KASEC in June 2012.

The "seven" have hired attorney David Day of Church, Church, Hittle, and Antrim to assist them with the legal dimensions of the transition.

The timing of various events is critical. Key issues currently under discussion are:

- a. When Western becomes the Local Education Agency (hopefully NLT July 1, 2011)
- b. An audit of all accounts associated with KASEC (this would protect both Western and Kokomo, the current LEA)
- c. Employment of teachers, contracts, etc.
- d. Employment of administrators.
- e. Inventory and distribution of KASEC assets.
- f. Employment of non-certified staff.
- g. Facilities and transportation.
- h. Division of remaining grant funds and any cash balances at the time that Western becomes the LEA.

The "seven" have also developed a modeling process that produces possible design scenarios for the new KASEC.

The "seven" are working very well together as they adjust to the realities of a decision-making group versus the advisory nature of the organization under Kokomo.

The relationship between the "seven" and Kokomo is, candidly, strained and unproductive. Much suspicion of motives on both sides. Something I worry about when one considers the benefits of a united Howard County education system, run by five equal partners. I would suggest that the Western School Board take a leadership role here and invite the other Board Presidents and Superintendents to a joint luncheon to discuss common interests??? What do you think???

## 2. Kokomo Area Career Center (KACC) update

I have been involved in a series of meeting with local superintendents and the Ivy Tech leadership personnel regarding vocational course offerings for our students.

My records indicate that KACC has seen a credit cost increase over the last three years as follows:

- a. SY 08-09: \$1,003.66/hr, based on 2,441 students
- b. SY 09-10: \$1,219.64/hr, based on 2,373 students; (21.5% cost increase, 2.7% student decrease)
- c. SY 10-11: \$1,369.71/hr, based on 2,158 students; (12.3% cost increase, 9.0% student decrease)

I have been and continue to be concerned on how we can match our credit cost with the decreases in student enrollment in KACC. This situation is even more painful when one considers that Western received a 3% deduction in state support, a projected flat lining of this support for the foreseeable future and teacher contracts with no increases for five years, (note that the bulk of the cost for vocational education is staff related).

The meetings with Ivy Tech are an opportunity to discuss the possibilities for high school students to participate in Ivy Tech classes, on their campus, for dual credit, at a cost of \$300 per credit hour.

Again, a discussion which would be made more productive in an environment of mutual respect, openness, and candor.

#### 3. Medical Clinic

If you will recall, one of the new concepts in the recently approved Master Agreement between WSC and WEA is the investigation of a possible medical clinic. To that end, I have met with representatives from Howard Regional Medical Clinic, and Dr. Nuss, both of whom are interested in developing a proposal for such a clinic in Russiaville. The next step is to arrange a meeting involving representatives from the WEA.

## 4. Kindness/Caring Group

I have formed a study group consisting of students, teachers, administrators, parents, pastors and social workers, focused on the development of a mutual program which defines WSC as a magnet school corporation for character and citizenship.

We have developed a draft VISION statement, which I hope to finalize in April 2011 (next meeting is April 12, 2011), then move forward with the more thorny 1<sup>st</sup> Amendment issues. Our goal is to implement the program in SY 11-12.

#### 5. Howard County 4 Community Effort

For the past three years I have been involved with a group of Howard County leaders dedicated to improving the success percentage of our poorer citizens. One of the neighborhoods identified as a pilot site is our own Pine Valley area.

As of this writing, and through the efforts of the 4 Community Group, the Kokomo Housing Authority (KHA), the Kokomo Mayor and WSC, we now have:

- a. A trolley stop at Pine Valley
- b. A homework tutor provided by KHA
- c. Personal contacts: I have gone door to door meeting kids (we have approximately 60 students in Pine Valley), and their caregivers, encouraging a more aggressive approach to educational opportunities provided.
- d. The planning for a reading intervention exercise this summer provided by WSC.

The hope is that the lessons learned at Pine Valley can be applied to our other poorer neighborhoods, who in total represent some 200 students. When one considers that this population represents around 8% of our total school population, and 32% of our "bottom" quartile, the academic performance of this cohort will have a significant impact on WSC future credentials – i.e. A, B, C, etc.

#### 6. WSC Leadership

Since coming to WSC, I have been convinced that the superintendency here should be perceived as an active, involved, and important one in Howard County educational and social issues. To that end, I have attempted to expand my presence and contribution in the immediate school district and in greater Howard County. For example, I am:

- a. The Chairperson of the Education Committee, for the Kokomo Noon Rotary.
- b. A member of the Russiaville Lion's Club.
- c. Visible at many WSC events.
- d. A member of the Board of Directors, IUK Advisory Council.
- e. A member of the Board of Directors of the IUK Athletic Council.
- f. A member of the Executive Board of the Howard County United Way.
- g. A member of the Howard County Partners In Education Group.
- h. An active participant in "Welcome to the Real World" and "Living in the Real World" activities.

Each of these venues allows me to increase WSC Corporation's visibility and contributions to the overall educational efforts of Howard County.

Most recently, I have been named as the "Campaign Chair" for the 2011 Howard County United Way Campaign. Thus far I have had the opportunity to visit with the heads of 16 agencies that support the needs of kids and parents, and will, over the next several months meet with the CEO's of 25 major businesses in our area.

#### 7. Thoughts on Legislation

I have been relatively silent on the legislative process this year, but I thought I would share a few comments:

- a. As the revenue picture continues to become more and more unpredictable, I felt and feel, that the best WSC could do was to make the expenditure side as stable as we could thus the 5 year Master Agreement with the WEA.
- b. Vouchers: The non-partisan Legislative Services Agency (LSA) estimates the fiscal impact of every bill. For HB1003, LSA has stated that the tuition support reduction for school corporations and charter schools would total \$2.9M for 714 scholarship-eligible students. By projection this figure to the cap of 7500 students in the first year, Indiana will divert \$30M from public schools to private schools in SY 11-12. Then, the savings to the state will be redistributed to ALL schools through the funding formula, not just to the schools which the voucher students vacated.
- c. The voucher bill states that an eligible school "is accredited by either the state board OR a national or regional accreditation agency that is recognized by the state board (like the American Association of Christian Schools and Independent Schools Association of the Central States). Also, there is no state review of the accreditation procedures of religious associations.
- d. I am not opposed to expanding the envelope on the "how" of educating young citizens (i.e. more charter schools, vouchers, etc.). I am opposed to experimenting in a time of very scarce resources, the results of which impacts on the public schools ability to do its job.
- e. Why is America currently so convinced that the institutions that made us strong and the envy of the world: churches, schools, municipal servants like police officers and firemen, etc. are no longer needed? In my opinion public schools have been the bedrock of our democracy and the centers of our communities.
- f. If statewide tuition support is straightened for 4 years at the 2010 distribution level, this will represent a cut to public schools since inflation, health insurance, utilities, etc. will continue to increase.
- g. The potential loss of the circuit breaker grant in HB1001 is a major concern.
- h. Cuts in the non-English speaker grant (forecasted to be 28%) are problematic.

Mrs. Carter informed the Board the refinancing of the Western School Building Corporation First Mortgage Refunding Bonds Series 2011 was successfully completed on March 16, 2011.

#### Item #9 - Credit Report from S&P

Mrs. Carter provided the results of a discussion she and Dr. O'Rourke had with Standard and Poor, which resulted in the corporation receiving an A+ credit rating for the school, by itself, without any state back up.

#### Item #10 - State Board of Accounts Audit

Dr. O'Rourke and Pam Carter provided the Board with a copy of the State Board of Accounts report on an audit performed for the time period July 1, 2008 to June 30, 2010.

#### <u>Item #11 – Resolution to Transfer Appropriation</u>

Mr. Wells made a motion to approve a resolution to transfer appropriation between classifications in the Western Middle School 2011 CPF Plan. Mr. Marley seconded the motion which passed 5-0.

Mr. McCracken provided a list of recommended textbooks to the Board for their review. Approval of the textbook list will be an agenda item for the May 2011 Board meeting. Mr. Marley engaged Board members, administrators, and Suzi Morgan, Primary School Teacher, in a discussion regarding the use of technology versus textbooks in the classroom.
