Minutes of the regular meeting of the Western Board of School Trustees held on Tuesday, June 16, 2009 at 6:00 p.m.

Mr. Marley opened the meeting with prayer, and Mr. Maugans led the Pledge of Allegiance.

Item #1 – Opening of the Meeting

Mr. Maugans called the meeting to order at 6:00 p.m.

Item #2 – Approval of the Agenda

Dr. O'Rourke indicated that he would like to add an additional item to the agenda regarding documentation to be signed by the Board President and Secretary to approve the resignation of Harris N.A. as prior trustee of Western School Corporation General Obligation Bonds of 2006, and the appointment of UMB Bank as successor trustee.

Additionally, Dr. O'Rourke said he would like to submit a correction to the summer school budget report.

Mrs. Singer made a motion to approve the agenda as amended by Dr. O'Rourke. Mr. Koloszar seconded the motion which passed 6-0.

Item #3 – Approval of the Minutes

Mr. Marley made a motion to approve the minutes of the May 19, 2009 regular meeting. Mr. Kenworthy seconded the motion which passed 6-0.

Item #4 – Opportunity for Public Comment

There were no comments from the public.

Item #5 – Panther Pride

- a. Dr. O'Rourke and the Board commended Clayton Carroll, a sixth grade student, SY 08-09, for winning the "If I Were Mayor Contest." Clayton was selected as the winner out of 3,700 contestants.
- b. Dr. O'Rourke recognized Western High School student Ryan Santana for his receipt of the 2009 Air Force Reserve Command Youth of the Year award.
- c. Dr. O'Rourke described the contents of a thank you letter from Mr. and Mrs. Duke concerning the efforts of the Western Middle School staff on behalf of their daughter Madelin.
- d. Dr. O'Rourke and the Board commended Western Middle School for its 100% pass rate on the Spring 2009 Indiana State end of course Algebra I exam.
- e. Mr. Maugans on behalf of the Board presented a Certificate of Achievement to Dr. Heather Hendrich for completion of her Doctoral Studies.
- f. Mr. Fields, Athletic Director, displayed a plethora of trophies representing various conference, sectional, regional and state championships won by athletic teams during SY 2008-09. Mr. Fields stated that 350 out of 811 high school students participated in athletics during the 2008-09 school year. Mr. Fields then described the new Western Academic Excellence Award. A student becomes a recipient of the award by participating in a varsity sport and maintaining the highest GPA among team members during that season. b. Director of Maintenance: Pat Grzesiak submitted the following report:

For the month of June 2009

Custodial

The Custodial crews are in full swing for summer cleaning and working around camps and summer school. Everything seems to be going well so far. On the 17th of this month, I will be taking 12 of our custodial and maintenance people to the workshop in Columbia City. This will give them a good opportunity for training and a chance to invest in their careers.

Building Projects

- ❖ The bus barn is near completion. We signed the letter of significant completion on the first of June. This is when all of our warranties start and we issue a punch list. The list is pretty short and nothing of real significant. We had the floors painted and hope to have the punch list done by the 19th of this month. I have poured the pad for the fuel pumps and will be installing them on the 12th of this month also. I am hoping that we can have our lettering put on by the meeting, but if not it will be coming in shortly. I am looking forward to showing you the latest addition to Western School Corporation.
- ❖ I will have the new mowing equipment at the garage for your viewing while you tour the new facilities.

- ❖ We have been very busy with Ethel Morgan, the engineer on the water project. Ortmans are getting ready to do the volume test once summer school is finished. We have to wait because I will shut down the Middle School well while these tests are run. Dr. O'Rourke, Ethel, and I will meet on the 16th with the first round of plans. If they are as we want, then they will be sent down to IDEM for approval and away we go. It is then we can start spending the grant money we received.

Mr. Grzesiak said he was waiting on the specifications and pricing from vendors. Mr. Grzesiak indicated that he would be able to provide some milestone dates for the water project at the July 2009 regular Board meeting.

c. **Director of Technology:** Mr. Taylor submitted the following report:

Summer Projects

- ⌚ We have completed all of the needed setup for summer school including a cleanup of Study Island accounts and creating accounts for students that did not attend during the regular school year.
- ⌚ Work is progressing with our projector installs. We should finish most of those installs this week with the exception of rooms that are having ceiling replacements this summer.
- ⌚ Cherie and Tammy have been doing some significant cleaning and updates in the computer labs.
- ⌚ We have started our list of employee adds/moves/changes and are working to make sure all accounts are ready for new employees and keeping the master phone list updated.
- ⌚ Equipment is starting to arrive for our new high school computer lab that will be in room 204 in addition to our first 1:1 classroom which will be in room 203. Our goal is to get the computer tables/furniture in place by the end of June. At that time we will need to install some power poles and implement our electrical and network wiring.
- ⌚ We have ordered a new server for our Lightspeed product which manages our content and e-mail filter. We need this new server in place by July 1st to accommodate our increase in Internet bandwidth which is scheduled to be installed by July 15th.

Additionally, Mr. Taylor informed the Board of some new software/hardware items associated with bringing the Dibels program to the Intermediate School.

d. **Assistant Superintendent:** Mr. McCracken submitted the following report:

1. Title I Grant Application Approval – the application will be reviewed at the meeting.

Total funds available for the 2009-2010 school year is \$250,788.50. This is down \$26,052.24 from last year (see attached).

2. American Recovery and Reinvestment Act (ARRA) of 2009 Part B, IDEA Recovery Funds for Services to Students with Disabilities (see attached)
3. Curriculum Mapping Update (see attached)
4. Summer School/Jump Start Staffing (see attached spreadsheet)
5. English as a Second Language (ESL) Handbook (see attached)
6. After-School Child Care survey conducted and the request for a waiver. I am requesting your approval to allow me to submit the waiver application to the Department of Education. (see attached)

Mr. Kenworthy made a motion to approve items 1, 2, 4 (as corrected), 5, and 6 contained in Mr. McCracken's report; Mr. Marley seconded the motion which passed 6-0.

e. Superintendent: Dr. O'Rourke submitted the following report:

1. Budget Matters/Special Legislative Session
 - a. The special session of the Indiana Legislature will begin at 1:00 p.m. on June 11, 2009
 - b. The Governor's proposal provides: a 2% increase for K-12 education for the biennium. The Governor's numbers include Title 1 and IDEA funds, both of which are categorical and may only be spent on students identified under these programs. The actual new state dollars are closer to .75% (2010) and .2% (2011).
 - i. 57% of school districts lose money compared to prior year revenue without counting stimulus dollars.
 - ii. \$5 million is included for scholarship tuition tax support (read vouchers), while funding is eliminated for new facility dollars.
 - iii. All school employees must be under the state health insurance plan by June 30, 2012.
 - iv. Elimination of funding for all professional development

2. Comments on Governor's presentation to Legislative Budget Committee, June 2, 2009, room 404 State House.
 - a. Presentation: "RIF notices in our state are a charade"
 - i. Comment: During the state's last budget crisis (2003-05 budgets):
 1. 595 certified instruction staff were cut
 2. 100 administrative staff were cut
 3. 595 classified staff were cut
 4. 100 instructional program offerings were cut
 - b. Presentation: "There is no excuse for laying off any teacher when there are so many administrators in this state. The burden of proof is on any administrator cutting staff and not his own position-maybe if there is a RIF situation the district needs to get a new Superintendent."
 - i. Comment: The above RIF data for 2003-2005 demonstrates that for every 6 certified instructional staff members RIFed, 1 administrator was also RIFed. As reported many times, originally from the Governor's chief of staff and educational liaison, the National Center for Education Statistics ranked Indiana 2nd in the nation in the ratio of teachers to LEA central office administrators (33.9 teachers to each administrator). The numbers ranged from 6 teachers per central office administrator in Arkansas to Arizona (1st place) 51 teachers per central office administrator.
3. Info about American Public Schools
 - a. Guess who made the following statements:
 - i. "The relative decline of American education is untenable for our economy, it's unsustainable for our democracy, it's unacceptable for our children."
 - ii. "In 8th grade math we've fallen to 9th place"
 - iii. "Of the 30 fastest growing occupations in America, half require a bachelor's degree or more"
 - iv. "Today's system of 50 different benchmarks for academic success means 4th grade readers in Mississippi are scoring nearly 70 points lower than students in Wyoming and getting the same grade"
 - v. "Only 1/3 of our 13-14 year olds are reading as well as they should"
 - b. Guess who made these:
 - i. "We have been lying to children and their parents because states have dumbed down their standards. Sometimes you have to call the baby ugly."
 - ii. "We're not just facing an economic crisis here in America. I'm absolutely convinced we are facing an educational crisis as well."

Item #9 – Athletic Transportation Fees (1st Reading)

Dr. O'Rourke indicated that during his first year as Superintendent (SY 07-08), he became aware of the fact that the corporation was assessing the athletic department \$25,000 per year to pay for the cost of athletic event related trips and that the full cost was around \$31,000. The athletic department was unable to pay the \$25,000 and continue to successfully support all of our athletic programs. Dr. O'Rourke decided to reduce the corporate assessment to athletics to \$10,000 per year starting with the 2008-09 SY. The total cost of transportation related expenses continues to increase and will no doubt be higher than the previous figure of \$31,000. Dr. O'Rourke asked the Athletic Director to develop a transportation fee schedule, submitted to the Board for 1st reading, to help defray some of this increasing transportation burden. Mr. Maugans asked about kids not able to pay. Dr. O'Rourke indicated that he and Mr. Fields had funds and procedures available to defray and/or eliminate the fee charges for these students. Mr. Koloszar asked Mr. Fields about the research used to develop the proposal. Mr. Fields said that he had surveyed several school corporations and had studied their fee schedules before developing the proposal. Mr. Kenworthy asked about the procedure to be used to determine which students would be required to pay and those that would not. Dr. O'Rourke indicated that he and Mr. Fields had access to data, such as free/reduced lunch information to help with this issue.
