- **3. Director of Technology:** Mr. Shearer submitted the following report:
- 1. E-Rate (helps to pay for Internet and other network connections) We have been increased from 52% discount to 60% discount because of new FCC rules. This will help the district save money on network hardware and Internet access costs out of pocket.
- 2. The digital sign out front is having issues with the east side. We are working to get the sign repaired and our messages to passing cars back up and running.
- 3. Skyward access was intermittent for a half day or so due to a configuration issue. The issue was resolved and access has been consistent since.

- 4. The four county schools (Western, Eastern, Northwestern and Taylor) were selected for the E-Learning Summer Conference grant for the second year in a row. This summer Northwestern will be hosting the conference at their place. Dates are set for June 15th and 16th.
 - 4. Director of Exceptional Learners and Testing: Mrs. Stranahan submitted the following report:

Special Education

SE report completed December 1. This is what generates the Additional Pupil Count (APC) funding from the State. Preliminary projections indicate that Western should receive approximately \$999,582. This is an increase from \$892,000 last year.

Testing

- Preliminary school letter grades have been provided to corporations, however, those are still under embargo and cannot be released at this time. Estimates indicate grades will be released January 15, 2016.
- The ISBOE issued a resolution for this year only, stating that students who passed either the CCRA in the Spring of 2015 or students who pass the new Grade 10 ISTEP+ in Spring 2016 may apply those results to the Graduation Qualifying Exam requirements.
- Experience Online Testing Pearson (ISTEP+ Grades 3-8, 10) opportunity is now available through Pearson. Experience is presented via the Pearson online platform (TestNav 8) that will be used for ISTEP+ online testing, as well as IREAD-3 online testing. The purpose of Experience is for students, educators, parents, and community members to see how test items similar to those on the ISTEP+ Part 2 assessment are presented in the online system.
- ISBOE and IDOE developing proposed growth calculations for Student-Centered Accountability System. This would base school accountability on how individual students perform from one year to the next, not the current system that compares one group of students to a different group of students. Anticipated adoption of this system is March of 2016.

- **5. Superintendent:** Mr. McCracken submitted the following report:

- 1. Elementary Fog Day The late fog on Monday, December 7th resulted in a cancellation for the Primary and Intermediate. This is now the second time this has happened, to my knowledge ever, both with me as the Superintendent. In the case on Monday, everything was totally clear when I checked the roads from 5:00 a.m. till 6:00 a.m. It wasn't until sometime between 6:30 a.m. and 7:00 a.m., that the fog started to come in and it wasn't heavy at the school until almost time for secondary students to arrive at school. The fog came in so heavy and dense when it did come in that we immediately delayed the elementary routes and when it was not lifting, we eventually cancelled school for the Primary and Intermediate. At the present time, calling an elearning day the morning of a cancellation is not an option, so we are now faced with how we will make up the day for the Primary and Intermediate only. The secondary students beat the worst of the fog in so they were able to have school. A lot goes into making a call like we did on Monday. I very much appreciate the teachers and staff that helped and helped us care for the students who were already here.
